- All participants must register at the Dip site on Echo Lake a minimum of 1 hour prior to the start of the jump.
- Challenge your friends, family, and community members to either agree to jump and raise \$100 OR donate \$20 in support of the Fire Department. FOR EXAMPLE, Susan decides she is going to jump this year and support the Fire Department. She will need to raise \$100 to jump. Susan then challenges her friend Joe to jump. Joe can either decide to take the plunge as well and begin to raise his own \$100 OR he can say, "Have you lost your marbles?" and donate \$20 to Susan.
- All dollars raised from the Polar Bear Dip will go directly to the Fort Qu'Appelle Fire Department.
